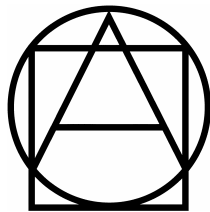

## **Board of Directors: Biographical Sketches**

### **Officers**

#### **Eric Bates - Co-Chair**

Eric Bates holds a B.A. in Communications and Political Science from Antioch College (1983), and an M.S. in Journalism from Columbia University, where he graduated with high honors, and has served as a visiting lecturer in public policy at Duke University, a trustee of Antioch University, and president of the Antioch College Alumni Association.

As investigative editor of *Mother Jones* from 1999 to 2003, Bates played a lead role in revitalizing the magazine, helping to restore its reputation as a source of in-depth journalism. During his tenure, *Mother Jones* earned the National Magazine Award for general excellence in 2001 and was a finalist for the honor again in 2003. In addition, he served for eight years as editor in chief of *Southern Exposure*, the region's leading political journal, where he oversaw groundbreaking investigations on factory farming, nursing homes and predatory lending. In his first year as editor, the journal received the National Magazine Award for public interest reporting, and was a finalist for the honor again two years later.

Bates has also received numerous honors as a writer, including the Thurgood Marshall Award for reporting on the death penalty, the Sidney Hillman Award for reporting on economic injustice, and the Pope Journalism Award for veteran journalists whose work demonstrates a commitment to social change.

He is currently one of the nation's leading investigative journalists, and serves as deputy managing editor of *Rolling Stone*, where he oversees reporting on political and social issues. Bates' work for the magazine has earned three National Magazine Awards, the profession's highest honor, including the 2007 award for general excellence.

#### **Frances Degen Horowitz – Co-Chair**

Frances Degen Horowitz holds a B.A. in Philosophy from Antioch College (1954), a Masters in Elementary Education from Goucher College (1954), and a Ph.D. in Developmental Psychology from the University of Iowa (1959). From 1985 to 1991, she served as a member of the Antioch University Board of Trustees and in 1983-85 was President of the Antioch College Alumni Association.

During her 30 years at the University of Kansas, Horowitz founded the Department of Human Development and Family Life, was Associate Dean of the College of Liberal Arts and Sciences,

and from 1978 to 1991 was the Vice Chancellor for Research, Graduate Studies and Public Service and Dean of the Graduate School. From 1991 to 2005, she served as President of the City University of New York Graduate Center.

Horowitz is the author of more than 130 articles, monographs, and books in developmental psychology with special emphasis on infant behavior and development and developmental theory. Among her honors, she is a Fellow of the American Psychological Association, a Fellow in the American Association for the Advancement of Science (AAAS), past-president of the Society for Research in Child Development, and in 2004 was elected a Fellow of the American Academy of Arts and Sciences.

Currently, at the CUNY Graduate Center, Horowitz is President Emerita, University Professor, and Interim Jack F. Skirball Director of the Center for Jewish Studies. She also serves on the Boards of the Hebrew Free Loan Society of New York, the New York Jewish Community Relations Council, the American Committee for the Weizmann Institute of Science, Congregation Ansche Chesed, the Black Rock Forest Consortium, the Board of Management of The Century Association, as chair of the Finance Committee of the Society for Research in Child Development, and is the editor of *Memoir Essays* for the Society for Research in Child Development.

### **David Goodman - Treasurer**

David Goodman holds a B.S. in Civil Engineering from Antioch College (1969), and an M.B.A. from Stanford University (1971).

For seven years, Goodman worked for Grow Tunneling Corporation, a legacy company founded by his grandfather, Charles Goodman, and a leader in constructing large municipal underground public works projects. While at Grow, Goodman served as Field and then Project Engineer and Business Manager on the New York City Water Tunnel, one of the largest public works projects in the country. He was Project Manager for construction work on the Atlanta Airport River Diversion tunnel in Atlanta, Georgia, among numerous other underground projects.

Goodman is a 36-year participant in the power generation, construction and asset investment marketplace and founded United American Energy Corp. (UAE) in 1980 with \$800 thousand, which grew steadily to over \$450 million of assets by December 2003. UAE was a privately held company that developed, acquired, owned and managed electric generating facilities. UAE, along with its partner Duke Energy, equally controlled and owned 100% of American Ref-Fuel L.L.C., the largest municipal solid renewable waste-to-energy company in the Northeast. Under Goodman's leadership, UAE also specialized in acquiring financially and operationally distressed power companies, and often functioned as a "white knight" for large lending syndicates in re-organizing such distressed companies by replacing management as one of the paths to revitalizing these companies.

He is a member of the American Society of Civil Engineers, the Moles, and the US Green Building Council. Goodman is also former president of the New York Alliance for Hydroelectric Energy, former director of the National Hydropower Association, former member and director of

the Electric Power Supply Association, and former member of the New York Independent Power Producers Association (IPPNY).

Goodman is a Principal of North Arrows L.L.C. ([www.northarrows.com](http://www.northarrows.com)), which specializes in power and energy investments. He is also a founding partner and operating principal of e-Solar Properties L.L.C., which is a green building real estate and property developer/owner/operator ([www.e-solarproperties.com](http://www.e-solarproperties.com)). Goodman has written and lectured on numerous subjects including Civil Rights and the summer of 1964, independent energy project financing, alternative fuels for heavy-duty vehicles, green building and general business matters in his areas of expertise.

He is the brother of Andrew Goodman and the President of The Andrew Goodman Foundation for Human Dignity and Civil Rights. Andrew was murdered on June 21, 1964 by the Ku Klux Klan with two of his co-workers James Chaney and Michael Schwerner while pursuing voter registration for African Americans in Mississippi.

### **Laura Markham – Secretary**

Laura Markham, Ph.D., is a clinical psychologist trained at Columbia University and holds a B.A. in Journalism from Antioch College (1980).

She launched the Metro Times, an alternative newspaper with a weekly circulation of 120,000 in Detroit, Michigan. By the time her company, Alternative Media Inc., was sold 18 years later, it had expanded to include weeklies in Orlando, San Antonio, and, briefly, Columbus. Markham subsequently served as Chief Operating Officer for Dragonfly Media, which published magazines in the green/alternative health niche in San Francisco, Los Angeles, Chicago, Seattle and Vancouver.

Markham is the founding editor of the website [YourParentingSolutions.com](http://YourParentingSolutions.com), and serves as the Parenting Expert for [ParentingBookmark.com](http://ParentingBookmark.com), [Storknet.com](http://Storknet.com), and [Pregnancy.org](http://Pregnancy.org), on which she hosts regular online chats for moms all over the country. She continues to work as a publishing consultant for websites and print publications, and has served on numerous boards, including those of Utne Magazine, Review Publishing, Dragonfly Media, The Goldensohn Fund for Investigative Reporting, and Antioch University.

## **Members of the Board of Directors**

### **Terry Herndon**

Terry Herndon holds a B.S. in Engineering from Antioch College (1957). He funded the Herndon Art Gallery at Antioch College and was a member of the Board of Trustees of Antioch College.

Herndon stayed on his last Antioch Co-op job at MIT (Lincoln Lab) for 40 years. He devised a number of chemical, electrochemical, electrical, optical, laser and ion implantation techniques for fabricating Integrated Circuit chips. Herndon consulted at MIT for five more years, working on adaptation of I.C. fabrication techniques to bio science applications. These included construction of an implantable artificial retina for patients with macular degeneration and making openings in the skin and nails painlessly to permit the transdermal delivery of drugs through the skin and nails.

He founded two companies dedicated to development of painless transdermal drug delivery techniques. Herndon has several patent applications for such technology. One technology has been sold to a drug company for further development. He holds a dozen patents and has published many technical papers concerning his work with I.C. fabrication technology.

Herndon has been active in Town Government having chaired the Planning Board, Board of Assessors and Board of Appeals. He founded KTR Engineering, a Ferrari automobile restoration firm. Herndon operated wheat farms and cattle feeding operations in Kansas. He has chaired the Board of Trustees of the Lars Anderson Automobile Museum, Brookline, MA, and the Board of Trustees of the Center for Collaborative Education, Boston, MA (a non-profit education organization that has developed the nationally-known Pilot School concept for K-12 public schools). Herndon funded a work program for 8th grade ghetto students at the Mission Hill School (a pilot school) in Roxbury, MA, and the Herndon Memorial Scholarship for a dozen high school graduates in Syracuse, Kansas. He has also built a theme collection of American Art of the 20th - 21st Century illustrating how our use of the automobile (and petroleum) has totally transformed the world's landscape and the human race.

### **Catherine V. Jordan**

Catherine Jordan holds a B.A. in Education from Antioch College (1972), and an M.A. in Law and Human Services from Antioch University.

Jordan has extensive experience in non-profit leadership, resource development, marketing, media production, and program design in the fields of education, arts and health. She began her career as the founder of a teenage peer education program and she has produced a number of films and videotapes illustrating prevention strategies including the award winning video, "ALL OF US AND AIDS."

She is the first President and CEO of Achieve!Minneapolis, a non-profit organization dedicated to building community partnerships with the Minneapolis Public Schools (MPS) to support student success. The organization raises private funds for major school reform initiatives and works with partner organizations to enhance Minneapolis Public School curriculum, improve teaching, transform high schools and increase career and post-secondary readiness.

Achieve!Minneapolis manages the STEP-UP summer jobs program for the City of Minneapolis that has placed over 1,700 trained 16-21 year old students in paid positions over the last four years. Jordan also spearheaded the creation of a new Career and College Initiative in all MPS high schools by establishing and staffing centers in each school so that every student has a plan for their future and support for college and career exploration.

Jordan received the 2007 Minnesota Vision Award for her leadership from the Minnesota Department of Employment and Economic Development (DEED) and *Positively Minnesota*, a consortium of higher education and government agencies.

Jordan is the co-founder of Peer Education Health Resources and founder of Capital New Year, the annual Twin Cities-wide arts and cultural festival. Jordan served as the president of the Twin Cities' United Arts Council, Executive Director of the Women's Art Registry of Minnesota (WARM Art Gallery), Managing Director of At the Foot of the Mountain Theater, Interim Director of the Girl Scout Council of Greater Minneapolis, and Interim Director of Circus Juventas (a circus school for youth).

## **Lee Morgan**

Lee Morgan holds a B.A. in Administration from Antioch College (1969). Lee served as a Trustee of Antioch University for 13 years and chaired the Development Committee during a successful capital campaign, which raised over \$50 million for Antioch College.

Morgan spent over three years in international work and travel before joining the Antioch Company (then the Antioch Bookplate Company). In 1997, he was selected as the Miami Valley (Ohio) Entrepreneur of the Year in the manufacturing category. Morgan is past Chairman of the Direct Selling Association and the Direct Selling Education Foundation, which awarded him their highest honor, the "Circle of Honor Award" in 2007.

He is Chairperson and CEO of the Antioch Company based in Yellow Spring, Ohio. The Antioch Company has manufacturing facilities in 3 states and sales operations in 8 foreign countries. The Antioch Company has been a pioneer in employee ownership, corporate social justice programs and triple bottom-line reporting. The Company was awarded the "Social Legacy Award" by *Business Ethics* magazine in 2002.

## **Stephen Schwerner**

Stephen Schwerner holds a B.A. in Secondary Education from Antioch College (1960), an M.A. in Student Personnel Services in Higher Education (1962), and an Ed.D in Counseling Psychology (1970) from New York University.

He interned at Queens College of the City University of New York in the counseling service from 1963-65. From 1965-1970, Schwerner was a member of the counseling staff, and from 1970-76, he was Director of the Counseling Service. While director, he was also President of the Metropolitan College Mental Health Association and a member of the directorate body on counseling of the American College Personnel Association. Schwerner served on the Queens College Academic Senate and chaired that group from 197-1976.

From 1976-1991, he was the Dean of Students at Antioch College in Yellow Springs, Ohio. During this time, Schwerner served on the Village Council of Yellow Springs and numerous Council committees. He was reelected to the directorate body of ACPA. In 1991, Schwerner was appointed Antioch College Professor and served on the faculty until his retirement in 2004. He has taught courses in education, psychology, peer counseling, cross-cultural studies, jazz history and the civil rights movement.

During the 1960s, Schwerner, along with the rest of his family, was very active in the civil rights movement and continues to lecture on the history of that period in American history. He has served as an evaluator for the Ohio Humanities Council, and continues to lecture on jazz history. He has and has had jazz radio shows on WYSO FM and WDPS FM for the past 28 years.

## **Barbara Winslow**

Barbara Winslow attended Antioch College until 1968, and holds a Ph.D. in Women's History from the University of Washington. She served on the Antioch University Board of Trustees 1995-2007 and is a member of the Alumni Board.

Winslow is a professor in the Women's Studies Program and in the School of Education at Brooklyn College of the City University of New York. She was the former Director of the Women's Studies and since 1945 has been the Project Director of the Shirley Chisholm Archive of Brooklyn Women's Activism. Winslow also is the Coordinator of the Interdisciplinary Social Studies Program.

She is the author of *Sylvia Pankhurst: Sexual Politics and Political Activism*, she has written numerous articles about women's political participation. She is currently completing *Clio in the Classroom: US Women's History*, a biography of Billie Jean King and a History of the Women's Liberation movement in Seattle, Washington.
